CREDENTIAL AUTHORIZATION

Per Education Code 44256 (b) which authorizes the holder of an elementary type credential to teach any subject in departmentalized classes to a given class or group of students below grade 9, provided that the teacher has completed at least 12 semester units, or 6 semester of upper division or graduate units, of coursework at an employees have met the requirements of Education Code 44256 (b) and thus require Board approval for the 2012-2013 school year.

Per Education Code 44258.7 (b) allow a full-time teacher who holds a credential in a subject other than physical education to coach a competitive sport for which the students receive physical education credit for one period a day, if that teacher has completed a minimum of 20 clock hours of first aid instruction appropriate to the specific sport. The following employees have met the requirements of Education Code 44258.7(b) and thus require Board approval for the 2012-13 School Year.

Per Education Code 44258.2, a teacher holding a secondary teaching credential may, with his or her consent, be assigned by action of the governing board to teach classes in grades 5-8, inclusive, in a middle school, if he or she has a minimum of 12 semester units, or six semester units of upper division or graduate units, of course work at an accredited institution in the subject to which he or she is assigned. The following employees have met the requirements of Education Code 44258.2 and thus require Board approval for the 2012-13 school year.

Per Education Code 44263, a credentialed teacher having 18 semester units of course work in a single subject, other than the subject listed on the credential, may be authorized with Board approval to teach that subject for one year. CREDENTIAL AUTHORIZATION cont.
