CREDENTIAL AUTHORIZATION

Per Education Code 44256 (b) which authorizes the holder of an elementary type credential to teach any subject in departmentalized classes to a given class or group of students below grade 9, provided that the teacher has completed at least 12 semester units, or 6 semester of upper division or graduate units, of coursework at an accredited institution in each subject to be taught. Board approval and teacher consent are required. The following employees have met the requirements of Education Code 44256 (b) and thus require Board approval for the 2012-2013 School Year.
