CREDENTIAL AUTHORIZATION

Education Code 44256 (b) which authorizes the holder of an elementary type credential to teach any subject in departmentalized classes to a given class or group of students below grade 9, provided that the teacher has completed at least 12 semester units, or 6 semester of upper division or graduate units, of coursework at an accredited institution in each subject to be taught. Board approval and teacher consent are required. The following employees have met the requirements of Education Code 44256 (b) and thus require Board approval for the 2020-2021 School Year.

Per Education Code 44258.2, a teacher holding a secondary teaching credential may, with his or her consent, be assigned by action of the governing board to teach classes in grades 5 - 8, inclusive, in a middle school, if he or she has a minimum of 12 semester units, or six semester units of upper division or graduate units, of course work at an accredited institution in the subject to which he or she is assigned. The following employees have met the requirements of Education Code 44258.2 and thus require Board approval for the 2020-2021 school year.

Per Education Code 44831, the governing board of a school district shall employ persons in public school service requiring certification qualifications as provided in this code, except that the governing board or a county office of education may contract with or employ an individual who holds a license issued by the Speech-Language Pathology and Audiology Board and has earned a masters degree in communication disorders to provide speech and language services if that individual meets the requirements of Section 44332.6 before employment or execution of the contract. The following employee has met the requirements of Education Code 44831 and thus requires Board approval for the 2020-21 school year.
