# A. <u>Annual Report – Richard Beck</u>

# B. <u>Project Status Report – Tina Koonce</u>

Tina Koonce reviewed the report explaining that Hemet High School Addition and Modernization are the highest priority. Currently under construction is the new pool and weight room at Hemet High School. Construction will begin on Phase 1A administration remodel, agriculture small engine repair classroom and ag upgrades, reroofing of the main building and installation of new underground utilities. This work will begin June 2009. The Cottonwood Library will be bid in May. The Acacia modernization project is on hold but still under review at DSA.

# C. <u>Financial Report – Tina Koonce</u>

Tina Koonce reviewed the financial report with the Committee. The Committee questioned expenses on furniture and equipment items. Mr. Beck stated that the expenditures were appropriate and legal.

## D. Analysis of Measure T Athletic Expenditures – Richard Beck

Richard Beck reviewed the Measure T athletic expenditures and explained the only athletic expenditures left are the gym and play field at Freedom Middle school. He feels that the overall athletic expenditures are reasonable in light of the fact that the state does not normally fund all the athletic needs and that they are more easily processed through DSA.
