- IV. <u>SPECIAL ITEMS</u>
  - A. <u>Project Status Report Tina Koonce</u>

Ms. Koonce explained the report stating the Cottonwood library was bid out. Mr. Beck said the original plan was to have a joint use agreement with the County of Riverside, but they weren't able to commit. Hemet High School is preparing for the remodel. Mr. Pulbrook inquired about the other sites listed for Measure T expenditures and Mr. Beck explained the modernizations would begin with the sites most needing attention.

B. <u>Financial Report – Joyce Brightman</u>

Ms. Brightman explained the \$40 million Series B bond has been received and disbursed. \$5 million went to Tahquitz Phase II and III and \$1 million each went to Page Ranch and Currie Ranch. The remainder went to site upgrades with most of it going to Hemet High and Acacia. Cottonwood was separated into two projects and we are hoping to get State money for the well. Hemet High School will be separated into separate projects on the next report. Rancho Viejo received \$13,790,607 in State Funds, which was \$1.8 million more than was anticipated. Because of this, we reduced the Measure T budget for Rancho Viejo by \$1.8 million and moved most of it to the Cottonwood project. Mr. Excell asked how close Tahquitz was to completion and Ms. Brightman advised all construction costs were encumbered but there will still be furniture and equipment that will be purchased over the next fiscal year.
